This authority will remain in effect until I have given written notice that I am terminating this agreement, or until Hilcorp has notified me that this EFT payment service has been discontinued. I agree that electing to participate in EFT payments will not amend any lease agreements with Hilcorp. This agreement simply allows for EFT payments in lieu of paper check payments. I understand that payment details on EFT payments will be available on the owner relations website and I can contact owner relations for instructions on retrieving payments details at OWNERRELATIONS@HILCORP.COM. I understand it is my responsibility to notify Hilcorp if any information contained on this form changes by completing a new form. I understand that I must give advanced notice to allow reasonable time for my instructions to be executed. I agree that Hilcorp will not be held liable for any interest or other claim arising as the result of my failure to provide written notice of any payment instruction changes. I also release and hold Hilcorp harmless for any loss, claim, damage, or interest incurred as the result of any financial institution's failure to properly or promptly post any EFT payment. If an incorrect deposit should be made into my bank account, I authorize my bank and Hilcorp to make the appropriate adjustment(s). I understand that Hilcorp will have up to ninety (90) days after receipt of the authorization form to process the EFT request. Note: If multiple owners are listed on the account both signatures are required.
