 - ___ Death Certificate
 - ___ Recorded copies of the decedent's Will and the Order admitting it to ancillary probate (*must be recorded where the real property is located*)
 - ___ Foreign Letters Testamentary and notarized copies of executor's deeds or other deeds, if applicable (*must be recorded where the real property is located*)
 - ___ W-9 Form completed by devisees

- To transfer the interest to the heirs if the decedent died without a Will (intestate) and the Estate is under Administration (Laws of Descent and Distribution will apply):**
 - ___ Death Certificate
 - ___ Affidavit of Heirship *completed by an unrelated party who knew the decedent well, signed in the presence of a notary, and recorded where the real property is located*
 - ___ W-9 Form completed by heirs

- To transfer the interest to the heirs if the decedent died without a Will (intestate) and no administration will be had, or with a Will which will not be probated:**
 - ___ Death Certificate
 - ___ Affidavit of Heirship *completed by an unrelated party who knew the decedent well, signed in the presence of a notary, and recorded where the real property is located*
 - ___ W-9 Form completed by heirs
