#### To remit payment to a beneficiary of a trust:

A certification or affidavit of trust containing all of the requirements set forth in W.S. 4-10-1014 showing the trustee's authority to transfer the property to the beneficiary

- W-9 Form for the beneficiary.

### To transfer the interest to the devisees/beneficiaries if the decedent's Will or intestate estate is probated in Wyoming:

- Death Certificate
- Recorded copies of the Will (*if applicable*) and the Order admitting it or the estate to probate
- Letters Testamentary or Letters of Administration and copies of executor's deeds or other deeds, if applicable *(must be recorded where the real property is located)*

Final Decree Determining Heirs or Devisees or Final Document of Distribution and Settlement (must be recorded where the real property is located)

W-9 Form completed by devisees

### To transfer the interest to the devisees/beneficiaries if the decedent's Will is probated in another jurisdiction and an ancillary or foreign probate is initiated in Wyoming: :

Recorded copies of the decedent's Will and the Order admitting it to ancillary probate *(must be recorded where the real property is located)* 

Foreign Letters Testamentary and notarized copies of executor's deeds or other deeds, if applicable *(must be recorded where the real property is located)*

## To transfer an interest to the heirs or devisees if Wyoming's Summary Distribution Procedure is utilized pursuant to W.S. 2-1-205

Recorded copy of the Decree of Distribution from a Wyoming District Court *(must be recorded where the real property is located)* 

\_\_\_\_\_W-9 Form completed by the distributees in the Decree.

# To transfer the interest to the heirs if the decedent died without a Will (intestate) and a formal Determination of Heirship has been established by a Wyoming district Court (Laws of Descent and Distribution will apply):

A recorded Decree of Determination of Heirship and W.S. 34-11-101 Affidavit (*if applicable for after discovered property*)

\_\_\_\_\_W-9 Form completed by heirs
